2. Presentation from the Maddox Interest regarding a possible amendment to Ordinance

Several representatives from the Maddox Interest were present to give a presentation to City Council and the Planning and Zoning Commission regarding a development on W Airport. The development would require a zoning amendment to the Meadows Place Code of Ordinance Chapter by amending Chapter 153.094 C-1 Light Commercial District, Section (B) to add subsection (l) Planned Development: Mixed Use – 55+ Adult Independent Living Facility as a permitted use.

After the presentation there was brief discussion among Council, the Planning and Zoning Commission, and the Maddox Interest regarding their development. No decisions were made during this meeting.
