### Splash Night & Town Meeting

Splash Night 2010 – What a great evening it was and what a wonderful tradition it is. I hope you all saw the big color photo in the STAR and the happy Meadows Place headline. I know it put a smile on my face. It takes a lot to make Splash Night work that well and my thanks go out to all the staff and volunteers that make this wonderful event possible. We served up 450 delicious hamburgers and nearly 300 hot dogs, chips, drinks and cookies. Beside the food, Kid's

favorites included a super slip & slide, a soap pond, and of course, the Oreo stacking contest. A great time was had by all as we lined the pool to watch the Lifeguard Cannonball contest. What a hoot – and it makes our community stronger.

Not everyone was there for the outside activities though, some came for the Town Meeting. We had another great turnout. Almost all the chairs filled and people were lining the walls. This year each Council Member gave a short dissertation on a topic they are currently involved with or is near and dear to their hearts. Shirley Isbell opened up by explaining to those in attendance how much a person has to learn and the commitment required to be on Council. Then Terry Henley took over explaining the past role of the EDC and what the conversion from a Type 4A to 4B will mean for Meadows Place. Dave Wilkens was next and talked about the importance of maintaining our property values through Code Enforcement and by taking care of what is ours by ourselves; Rick Staigle then brought us up to date on the W. Airport reconstruction Project and some of the snags we are working around. Heidi Case finished up with an update on Phase IV of our Parks Improvement Grant from Texas Parks and Wildlife. This included an update on the Public Works Water Reclamation Project that will provide the water for the lake and for irrigating our parks and esplanades. The overheads of the lake were spectacular and, as she pointed out all the amenities that will be included in the project, she held up two bottles of water - one bottle of reclaimed water from our plant and an unopened bottle of Ozarka. You couldn't tell the difference! There was a short Q&A and then we were off to enjoy the festivities. Thanks to everyone who participated and helped make Splash Night so special, once again making Meadows Place -Your Place for Life.

### Strategic Planning Session

Last month your Council spent the better part of their Saturday in a Strategic Planning Session. Council used our Vision Statement as the platform from which to operate and came up with 25 ideas to help keep Meadows Place moving forward so we can continue to have a City people will want to move into. This was just Phase I, of this project. Phase II will have Staff get together, and using Councils ideas as a base, will build upon, add to, refine and prioritize these ideas from a front line point of view. Later this year, these ideas will then be brought to a joint session of Council & EDC in order to select projects and determine what role the EDC can play in long-term financial support. Looking forward will prevent us from falling behind.

**Did you know...** trash cans should not be visible other than on trash days Tuesday & Fridays? Siding can be pressured washed, too.



- Trim trees and bushes back (Way Back)



Classmates, MySpace, Facebook, Windows Live Spaces, Twitter – these are but a few of the ever-growing list of social networking sites available through the Internet. Whether


or not you "social network" through any of these sites, it's all we hear about whenever we turn on the TV, radio, or browse the Internet. Millions use social networking to keep in touch with friends from high school and college, former co-workers, family, and countless others. Some live and breathe it – constantly checking up on others and posting up-to-the-second information and photographs of themselves.

Like so many other things in our rapidly evolving technoworld, unexpected consequences are often lurking behind the next keystroke. Almost daily we read about new privacy issues pertaining to social network sites and the information posted therein. Simply put, we have to be aware of the potential risks of having a social networking profile. Do you ever stop and think that posting something that might be questionable or inappropriate now could come back to haunt you later? One example is that employers are increasingly checking social networking histories of applicants. Here are a few reminders from the National Crime Prevention Council to help you network safely:

- Read through the privacy options carefully and make sure you thoroughly understand your rights.
- Set your profile to private so only the people you want to see your file can.
- Only "friend" people you actually know if they're not your friend in real life, why would they be your friend on a social network?
- Be aware that whatever you post online may never truly go away, so be mindful about what you share online.
- Keep in mind that whatever "private" information you post is there for people to see. Think twice about posting things like your address, phone number, or other personal information you don't want everyone to know.
- For their children's protection and safety, parents should educate them regarding social networking and closely monitor what they're doing online.

# **Swimming Pools**

posted some of this information last year in an article, but swimming pool safety is a serious matter and I figured we could all use the reminder. As of today, so far in Texas, 34 children have drowned. With the

bulk of the summer still to come, my hope is that we can be forever mindful of the risk of a child left unattended near a pool.

Any swimming pool, hot tub or spa that contains water greater than 24" in depth is required to be completely surrounded by a fence. Fences must be at least 4 foot in height, and gates must have a self-closing and selflatching mechanism 54 inches above the bottom of the gate.

In addition to providing a mandatory barrier around your pool, keep the following in mind;

- If a child is missing, always look first in the water.
- Even a person who is a strong swimmer can drown.
- Keep rescue equipment and a phone near the pool.
- Learn cardiopulmonary resuscitation (CPR).
- Place an alarm on any door leading to a pool.
- Remove step ladders from above ground pools when not in use.

Swimming pools must be maintained in a clean and sanitary manner. Water that has become stagnant is not permitted, and must be emptied and cleaned properly.

Failure to properly enclose and/or maintain a swimming pool or spa can result in a fine of up to \$2,000 per offense.





# Our Drinking Water Meets or Exceeds All Federal (EPA) Drinking Water Requirements

This report is a summary of the quality of the water we provide our customers. # DEFINITIONS

# Maximum Contaminant Level (MCL)

The highest permissible level of a contaminant in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

# Maximum Contaminant Level Goal (MCLG)

The level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

# Maximum Residual Disinfectant Level Goal (MRDLG)

The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

# Treatment Technique (TT)

A required process intended to reduce the level of a contaminant in drinking water.

# Action Level (AL)

The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
