# ECONOMIC DEVELOPMENT CORPORATION REGULAR MEETING MINUTES FEBRUARY 19, 2014

# 3. Election of President, Vice President & Secretary

# 6. Ad Hoc Committee Reports:

a. Retail Property Update

Vice President Graf reported on the potential development of vacant land located at the intersection of Kirkwood Road and West Airport Blvd. Aldi was discussed as a potentially good fit for the location.
