Adjourn the Executive Session, stating that date and time the Executive Session ended and Reconvene the Special Session.

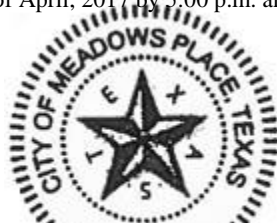
E. SPECIAL SESSION CONTINUED
