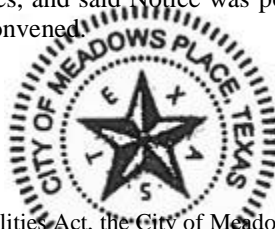
MEADOWS PLACE CITY COUNCIL SPECIAL SESSION MEETING
