Meadows Place City Council Special Session Meeting

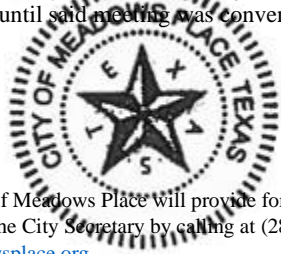
